The Farm Safety Program (FSP), established in 2016 is a program administered by Keystone Agricultural Producers (KAP), that provides safety advisory services and training opportunities to all Manitoba farmers at no cost. FSP's activities are directed by a safety council of local producers who provide the program with industry-specific insight and expertise.





OUR CHALLENGES

Farming continues to be the most dangerous occupation in Manitoba, and the rate of farm accidents has negatively impacted agriculture's reputation with consumers and the public at large. Our greatest challenge is getting safety resources into farmers' hands. Farming in Manitoba becomes more time consuming and complex every year. The idea of adding farm safety training to an already long to-do list can be daunting. As a result, producers don't seek out our services until an injury occurs or a safety officer visits their farm. We want your help bringing resources to farmers' before this happens to let them know how they can benefit from participating.


OUR SUCCESSES

In just over a year, FSP has trained nearly 450 farmers on topics including workplace safety and health legislation, emergency response planning, hydrogen sulfide safety, first aid and safety committees. These sessions take place in everywhere from small rural communities, to larger centres like Brandon, Winnipeg, Steinbach and Portage.

Our on-farm advisory services receive the greatest uptake and as word spreads the numbers of requests steadily grow. Our consultant's first priority is educating producers on Manitoba's workplace safety and health legislation, and what safety officers look for during inspections.
